- Certificate of Responsibility: Bidder must be qualified under Mississippi Law and must show a current Certificate of
 Responsibility issued by the Mississippi State Board of Public Contractors establishing the classification of work the
 bidder is authorized to perform.
- **Bidder Identification**: Each bidder must write their Certificate of Responsibility Number on the outside of the sealed envelope containing their proposal.
- Bid Submission: Proposals must be submitted in duplicate, sealed, and deposited with Madison County prior to the
 hour and date hereinbefore designated. No bidder may withdraw their bid within 90 days after the actual date of the

- Qualification Information: Each bidder must submit a separate attachment stating their qualifications to perform the
 work, including a list of past projects of similar size and nature, a list of references, and key personnel who will perform
 the work.
- Non-Resident Bidder Information: Awarding public contracts to non-resident bidders will be on the same basis as the
 non-resident bidder's state awards contracts to Mississippi contractors bidding under similar circumstances. Nonresident bidders must attach a copy of their resident state's current laws pertaining to such state's treatment of nonresident contractors.

 process.
